Since 1 September 2018 in High Wycombe, 1 January 2019 in the Great Holm area of Milton Keynes and 1 April 2019 for the remainder of Buckinghamshire and Milton Keynes, the level of hoarding has been recorded as a numerical entry for premises where it is known to be present. The numerical entry is determined by the clutter ratings which are used across housing, social care and fire and rescue services to indicate the level of accumulated belongings in a standardised manner. Information collected is retained for a period of no more than 8 years being electronically deleted in the seventh year. This indicates that there are 77 premises with hoarding at level 5 or above. The type of material being hoarded is not recorded in this system unless it presents a biological hazard to attending firefighters e.g. used incontinence products. The number of properties which fall into this category is statistically too low to be released as it may be identifiable.

Further to your request for information about the Buckinghamshire & Milton Keynes Fire Authority fleet list of all operational vehicles including their callsigns, information on our red fleet is published on our website: https://bucksfire.gov.uk/about-us/#our-stations-block_5e7efe855c1f8 under each individual station.

In respect of their callsigns, I confirm that Buckinghamshire & Milton Keynes Fire Authority (the Authority) does hold this information.

However, this information is exempt under section 24 of the Freedom of Information Act 2000 - the retention is required to safeguard national security; and section 36(2)(c) of the Freedom of Information Act 2000 - if disclosure, in the reasonable opinion of the Authority's qualified person, would or would be likely to prejudice the effective conduct of public affairs.

The Authority provides a fire and rescue service to the areas of Buckinghamshire and Milton Keynes and has a duty to its employees, its partner agencies, and the public to ensure that its operational information is appropriately protected; and that its employees and resources are protected when deployed to incidents.

The release of this information has wider implications that have to be considered and if this information were disclosed it may prejudice the Authority's ability to conduct its fire and rescue service obligations effectively and to maintain its own security and national security. Maintaining security and ensuring public safety, and the safety of the Authority's employees deployed to incidents, take precedence over this request.

There is strong public interest in transparency, allowing the public to know how many vehicles we have and providing reassurance regarding the level of capability in Buckinghamshire and Milton Keynes.

By providing a link to fleet list of the numbers, class, make, model, and registration mark of vehicles, I believe the Authority has met this public interest.

The strongest reason favouring non-disclosure of the callsigns is the need to ensure that national security and the employees and resources of the Authority are not placed at risk, by enabling those with malign intent, the opportunity to gain an advantage over the fire and rescue service.

It is therefore considered that the public interest in withholding part of the information you requested outweighs the public interest in disclosing it.

Could you please tell me how often fire hydrants are serviced and whether during a fire emergency at a non-hazardous waste treatment facility you would be able to use water contained in an underground tank with a standard manhole access to insert a pipe.

Response:

Further to your request for information, about Fire Hydrants, I can confirm that waste storage and recycling centres are regulated by the Environment Agency. Please see the Environment Agency Fire Prevention Plans, which should assist you.

The table on page 9 details a maximum volume of waste to be held in any single pile. Page 12 then gives a way of calculating how much water needs to be available to extinguish that size of pile.

The figure used in the example is 2000 litres per minute and that amount of water is not attainable from a hydrant on a domestic water main. Therefore, a dedicated fire main and a high volume water storage facility are normally required. The private hydrants on a dedicated main should be serviced annually by the site owner/operator. In practice, if you don't have enough water on site, then you have to reduce the size of your piles.

Fire service hydrants on water company mains are serviced on a rota basis. The National Guidance Document suggests once every four years and Buckinghamshire Fire & Rescue Service (BFRS) achieve 3 ½ years or less. An underground water tank would need to be visited and deemed to be suitable for BFRS use. Frank has covered the key points here, hard standing and access for a 24 tonne fire appliance, volume of water, proximity to the fire, ability to draw all the water from the underground tank if it is deep. On larger risk sites a Site Specific Risk Assessment (SSRA) would be carried out by the Fire Crew and any large water supplies would be recorded. If deemed suitable this would be added to the Site Specific Risk Information (SSRI). So, if we know it is available and are happy about the origin of the supply and quantity of water it could be used for firefighting purposes.

This was a recommendation from the Grenfell Phase one report and is not currently a requirement. To become a requirement, this will require a legislative change. Once any of the recommendations become regulations, building owners / managers will then be required to do this.

2. Has your fire and rescue service developed any policies for handling a large number of Fire Survival Guidance calls simultaneously?

BFRS is part of a Thames Valley Collaborative Control Room function, which will have procedures for dealing with fire survival guidance, along with fall back arrangements as resilience.

3. How many owners/managers of high-rise buildings have provided your local fire and rescue service with up-to-date plans in both paper and electron form of every floor of the building identifying the location of key fire safety systems?

This is part of an ongoing programme between our fire safety and response departments. We currently have records relating to 71 High Rise premises across Buckinghamshire and Milton Keynes. These encompass solely commercial, solely residential and mixed use. A dedicated team work with response crews to ensure operational response plans are up to date, including building lay out.

4. How many owners/managers of high-rise buildings have provided your fire and rescue service confirmation that there is a premises information box which contains a copy of the up-to-date floor plans and information about personal evacuation plans for residents who may struggle to do so.

Premises Information Boxes are not yet routinely used by all high rise buildings, again this is a recommendation from the Grenfell Phase one report and not yet a requirement. When/if this recommendation becomes a requirement, the handling and maintenance of the information stored will need to be agreed. As the security of personal information is a concern.

We still attend all AFAs, unlike the majority of fire and rescue services in the UK.

However, the public and the media have shown little interest in these incidents over the years. Since we stopped publishing AFA attendance details at the end of March 2020 I am aware of three enquiries from the public and none from the media. We have been keeping a close eye on feedback and will do our best to make changes in the event of a significant weight of opinion from website users.

However, we have to run a very tight ship here because of the squeeze on public expenditure, so we would need to be able to justify that resourcing the reinstatement of AFA listings (and the other incident categories that no longer appear in the list – bonfires and non-AFA false alarms) represented better value for money than, say, the increased level of public safety messaging we are now able to provide.

2. Why are assistance, when given to neighbouring authorities, not recorded. Bucks indicate where they receive assistance from others.

Buckinghamshire Fire & Rescue Service (BFRS) is responsible for the areas served by Buckinghamshire Council and Milton Keynes Council (ie the ceremonial and historic

county of Buckinghamshire). We endeavour to list all incidents of interest which happen within our boundaries. This includes listing any non-BFRS fire appliances and crews in attendance.

Our neighbouring fire and rescue services are responsible for making their own arrangements with regard to publicising incidents within their boundaries and deciding how much detail to provide. Therefore, we do not generally cover these, even if BFRS fire appliances and crews attend, unless they are of major regional or national significance or occur on a motorway near the Buckinghamshire and Milton Keynes borders and are likely to have had an impact on people travelling within the area we serve.
