I'm a researcher at the University of Greenwich in London, exploring fire risk for people living with dementia and any initiatives in place to reduce risk for this group.

I wondered if you could share with me the number of fire incidents you attended which involved people living with dementia in the last reporting year?

Do you have any strategies or policies in place regarding people living with dementia? If so, it would be great to see those.

Response:

Buckinghamshire Fire and Rescue Service do not record dementia status for people who have experienced a fire so are unable to fully respond to this request. Please accept the following information in partial response.

In the reporting year from 01.04.2023 up to 19.02.2024 we have completed 4,276 preventative Home Fire Safety Visits, of which 311 were to people with dementia status recorded as yes. Of these 311 people, 6 Home Fire Safety Visits were completed as post incidents following a fire event.

The Service records dementia status during these visits as it is an agreed vulnerability factor due to the potential for the person with dementia not being able to respond adequately to or evacuate a building in the event of fire.

The National Fire Chiefs Council advocates the person-centred approach to Home Fire Safety Visits which the Service follows, the guidance for which has references to dementia and fire risk. That guidance also includes background research references: [Person Centred Framework Guidance - NFCC](#).

The Service also aligns to the National Fire Chiefs Council's Equality of Access guidance document [Equality of Access to Services and Employment for people living with dementia - NFCC](#) which is a document that feeds into fire and rescue services Community Risk Management Planning (CRMP) processes.

Additionally, the Service has a dementia friends e learning package which is optional for completion and has run dementia friends sessions on station to raise awareness amongst front facing staff who may interact with the public. The attendance numbers for these are however not recorded.
